Andrew Benson-7737 2<sup>nd</sup> Ave house is rented Dec. 5, 2023. Monthly rent is \$2350, up from \$2200. Rent includes \$50/month for a small pet. 18-month agreement. \$6000 was allocated for repairs (recommendation of finance committee) was spent on structural repairs and approved during October 17, 2023 Vestry meeting. Actual structural repairs and refurbishing expenses totaled approximately \$9.800. Andrew and Gretchen to work with finance committee to figure out from where (accounts) the extra money is coming from. Andrew also reported he is looking for new gardeners to maintain all 4 rental properties.
