Collapsed financials:

\$44,000 less than anticipated revenue.

\$10,347 – less expenses

-\$5,877 in the red.

\$6,000 in the hole is projected.

Comes out of general fund.

Fundraising still coming in.

Rentals approx. \$20,000 less than anticipated.

\$10,000 from audit – added to Gen Op Funds.

Special Funds:

\$15,000 in pledges

Interest available next year from Cap Fund endowment \$10,985.

All rentals rented!

Staggered to not all come due at once.

May be more funds available from rentals.

Preliminary 2025 budget review:

Pledges: 367 received and reasonable idea of pledges that are expected.

Lower than last year.

Have lost more pledges than we gained.

Expenses are preprogramed, very little leeway.

\$102,000 operating shortage.

-\$76,000 next year.

Cannot make up shortfall by doing things as usual. Will need to increase fundraising.

Planning for insurance – expenses for priest, spouse, children.

Presuming a supplemental pledge drive/fundraiser.

Getting different lease on elevator (Spring) will be helpful.

Have we tried to rent out our space more?

Presenting Budget to Finance Committee with all its issues. Presuming there will be fundraising.
